STEPS FOR APPLICATION

GENERAL REQUIREMENTS

You should have minimum IELTS Score for :

- Bachelors - 6.0 Bands / Masters - 6.5 Bands

Funds for one year Tuition fees and living expenses :

- AUS \$ 19,830 should be shown for Principal Applicant (Recommended)
- AUS \$ 6,940 for Spouse (Recommended)

DOCUMENTATION GUIDELINES

- Documents should be scanned properly and the text should be legible.
- All documents should be in English or Translated in English otherwise.
- Photocopy of both Original and Translation should be submitted.
- Documents should be certified that is true copy (if applicable).

* Financial Documents

- Bank Statements Saving Bank Account (for the last 5-7 months as per the subclass certified by the bank)
- Fixed Deposit - copies certified by the bank (maintained as per the Subclass)
- PF/CPF/GPF-Annual Statement + Covering Letter with withdrawal value (certified by the concerned department)
- Public Provident Fund - Pass Book + Covering Letter with withdrawal value (certified by the Bank)
- Bank Loan Sanctions letter + Security documents + Loan Disbursement Letter - valid for course duration (if applicable)
- Property Ownership + Valuation provided by bank (if property is mortgaged)
- Personal Loan or Overdraft Limit (with security documents-valid for course duration)
- Self-Affidavit. (On stamp paper notarized)
- Financial Declaration Affidavit (On stamp paper notarized) from student for Level 1 Universities only.
- Affidavit from parents (on stamp paper notarized)
- Income proof (Income Tax Return for last 3 years)
- Employment proof / Business proof / Agriculture Income proof.
- Relationship proof (if required)
