STEPS FOR APPLICATION

- 1) Counseling by our expert counselor and providing all relevant information
- 2) Retain with future link consultants and make the payment for the services
- 3) Sign Retainer Agreement and start submitting documents as per the checklist given at the time of counseling.
- 4) The documents would be reviewed by us to ensure the completeness and accuracy.
- 5) Once we receive the complete information and documents as per the checklist from your side, we will start with the application process.
- 6) Once your application is submitted to TT Services, you will be updated.
- 7) For New Zealand student visa, Embassy may take the interview.

GENERAL REQUIREMENTS

- You should have minimum IELTS Score of 6.0 Bands - 6.5 Bands.
- Living Expenses of NZ \$ 15,000 (Recommended) may come under FTS. (Fund Transfer Scheme)

DOCUMENTATION GUIDELINES

- Documents should be scanned properly and the text should be legible.
- All documents should be in English or Translated in English otherwise.
- Photocopy of both Original and Translation should be submitted.
- Documents should be certified that is true copy (if applicable).



* DOCUMENTS CHECKLIST FOR ADMISSION & VISA PROCESS

* Identity Proof

- Passport
- Old to latest passports (all pages)
- Passport Size Photograph

* Academic Documents

- From previous Course/College
- Mark sheets of all education Completed
- Transcripts
- Degree Certificate
- IELTS/PTE Score Sheet

* Financial Documents

- Funds for Tuition fees and living expenses should be shown for the duration of program.
- Educational Loan Sanction letter from nationalized or multinational bank only.
- Bank Statements / Bank Passbooks for past 6 months, not more than one week old at time of visa file lodgment.
- Fixed Deposits -along with letter from bank giving details of deposits.
- Public provident fund accounts/Employers provident fund accounts.
- Authorization letter from Guarantor authorizing NZ embassy to verify their financial documents on their behalf. (Affidavit of support from Guarantor).
- Applicants need to provide evidence of income and source of income of their parents even if cost of study is being sponsored by another person.
- Last 3 years income tax papers of all family members/Form 16B / Agriculture income proof/
Business income proof.

- Medical Certificate from Panel Doctor
- Police Clearance Certificate
